#### Who are we?

### What information do we collect from you?

- We collect information about you when you become a supplier to us or customer with us or place an order for products or services.

  their business from their home address. All information is stored for the purposes of
  conducting legitimate business.

# Why do we collect this information?

 We collect information about you to enable us to provide products or services which you have purchased from us.

### Who might we share your information with?

- We may share your personal information with third party suppliers, such as couriers or hauliers, to allow us to deliver the product or service which you have purchased.
- We do not share your personal information with any other company unless we need to for us to provide the product or service to which you have purchased from us.
- We will never pass on your personal information to other companies for marketing purposes.

### What do we do with your information?

- We may store some information about you for a longer period on historical backups or due to external regulations imposed on us as a business (for instance by HMRC).
